Results

The difference in trends that we see in the comparison tables above is down to many factors. In the Republic of Ireland there is a smaller supply in relevant talent, thereby increasing the minimum average offering in each position. As we approach the more senior positions in the U.K we have a higher offering, as the size of the organisations is generally bigger and they have an increased demand in the required skill sets of the candidates entering these positions.

On the Irish side, in the lower to middle end of the salary brackets for each position there is generally a reduced offering in benefits such as healthcare, pension or dental. It is also worth noting the higher taxes that a PAYE employee will have to pay in the Republic of Ireland when compared with the U.K.

Overall, we are not only seeing an increase in the amount of talent returning to Ireland, but new talent attraction is also on the increase given the current Brexit uncertainty and the change in tax law in the U.K.
